OVERVIEW

Funding Opportunity

The United States Department of Housing and Urban Development (HUD) issues a Notice of Funding Opportunity (NOFO) for Continuum of Care (CoC) Program funds for housing programs and services for people experiencing homelessness annually. The Tucson Pima Collaboration to End Homelessness (TPCH) is designated by HUD as the AZ-501 Tucson/Pima County Continuum of Care and is responsible for preparing the CoC's application for HUD CoC funds.

All projects funded through the FY 2024 Continuum of Care Program and Youth Homelessness Demonstration Project NOFO are eligible for renewal in the FY 2025 Continuum of Care Program Notice of Funding Opportunity **without submitting an application**. Projects funded prior to the FY2024 funding cycle, that end in calendar year 2026 are eligible for renewal in the FY2025 funding cycle, and **these projects will be required to submit project applications**. For Tucson/Pima this only includes projects funded through the Unsheltered Set-Aside (SNOFO) funding. New projects, expansion projects, and bonus funds are not available during this funding cycle. The TPCH Board also voted on January 13, 2026 to only accept renewal projects, therefore reallocation applications will also not be accepted.

The FY 2024-2025 CoC Program NOFO was re-opened by HUD on January 9, 2026 and is available at the [FY 2024-2025 Annual CoC Program NOFO landing page](#). Consistent with HUD requirements, TPCH is administering the local application process for renewal for CoC and YHDP Program grants ending in Calendar Year 2026.

This document outlines the process for submitting renewal project applications for Unsheltered Set-Aside projects under the [FY 2024-2025 CoC Program NOFO](#). To ensure compliance to regulations and guidance provided by HUD, TPCH reserves the right to amend these requirements and/or issue additional instructions, clarifications, or corrections as needed.

These instructions are not a substitute for reading the [FY 2024-2025 CoC Program NOFO](#) and do not include all instructions, requirements or details provided by HUD. Applicants are strongly encouraged to read the [FY 2024-2025 CoC Program NOFO](#) and [supporting documents provided](#) in order to prepare a complete, accurate, and responsive application for funds.

Key Dates

All times listed are in Arizona time (MST, UTC-7). Due to tight deadlines provided by HUD, late submissions will be rejected.

CoC Renewal Project Applications

All current CoC-funded projects with contracts ending in calendar year 2026 are eligible for renewal through this NOFO. **Renewal project applications specific to addressing unsheltered homelessness are due by 11:59pm Arizona time on January 22, 2026.**

The information provided in this section does not apply to Youth Homelessness Demonstration Project (YHDP) non-competitive renewal projects or CoC projects funded in FY 2024.

Applications submitted after 11:59pm on January 22, 2026 will be rejected due to the tight deadline provided by HUD. Incomplete submissions will be deemed late and may be subject to the same penalty.

Intent to Renew

As communicated by email on December 30, 2025, each existing CoC and YHDP project was asked to submit a response to the Renewal or Reallocation Survey no later than 11:59pm Arizona time on January 7, 2026.

Materials for Renewal Applications for Addressing Unsheltered Homelessness

Project applications must be submitted electronically via the eSNAPS portal, as well as an export sent via email to tpch-nofo@tucsonaz.gov:

1. **ESNAPS Renewal Project Application:** Projects must complete and submit the HUD Renewal Project Application including all required standard forms, certifications, and attachments. The HUD Renewal Project Application is submitted online using HUD's web-based eSNAPS platform and is available at <https://esnaps.hud.gov/grantium/frontOffice.jsf>.
2. Attach an export of the project application from eSNAPS and email to tpch-nofo@tucsonaz.gov. This is due no later than 11:59pm on January 22, 2026.

CoC Renewal Project Performance Score Card

The HMIS Lead started preparing performance scorecards for all CoC renewal projects beginning August 15, 2025. Project performance will be considered in edits to the priority listing. The scorecard reflects data submitted within the Homeless Management Information System as of June 30, 2025.

Evaluation Criteria

TPCH CoC Project Performance Score Cards

The HMIS Lead prepared the TPCH CoC Project Performance Score Card for all grants eligible for renewal in the FY 2025 CoC Program funding competition. The TPCH CoC Project Performance Score Cards was distributed through the TPCH email distribution list and posted online at tpch.net on December 1, 2025.

Performance scorecards will be reviewed and consulted by TPCH board members as part of updating the CoC Priority Listing for the FY2025 funding cycle.
